

This Tender was uploaded on our office website on 10.09.2015 & 06.10.2015. The last date for submission of Quotations was **14.10.2015**.

In response to the above said Tender Notice, three bidders had submitted their bids wherein two bidders namely M/s Varsha Industrial Security Services, Vadodara and Labour Supplier and M/s K.C. Electrical and Traders, Vadodara did not qualify technically as per the provisions and terms & conditions laid down in the Tender Documents I to IV.

The only one bidder namely M/s Param Enterprise, Vadodara has been found technically qualified and as per the provisions of GFR and para 11.7.3 and 11.7.4 of 'Manual on Policies and Procedures for Purchase of Goods' the said Tender was finalised in favour of **M/s Param Enterprise**.
